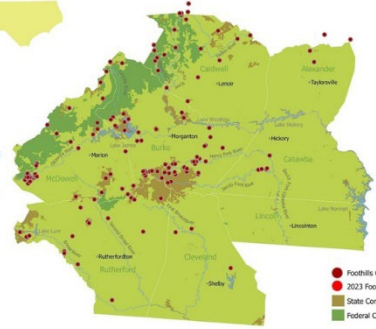

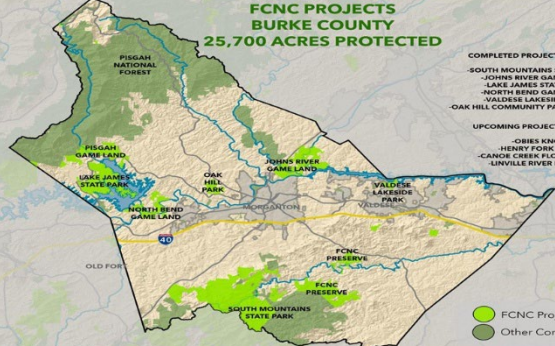
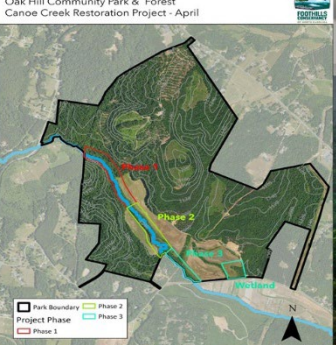
FCNC – INFORMATIONAL UPDATE FROM FOOTHILLS CONSERVANCY OF NC

Shane Prisby, Trails Program Director, Foothills Conservancy of NC, announced that Andrew Kota, Executive Director, Foothills Conservancy of NC, was unable to attend the meeting, and relayed

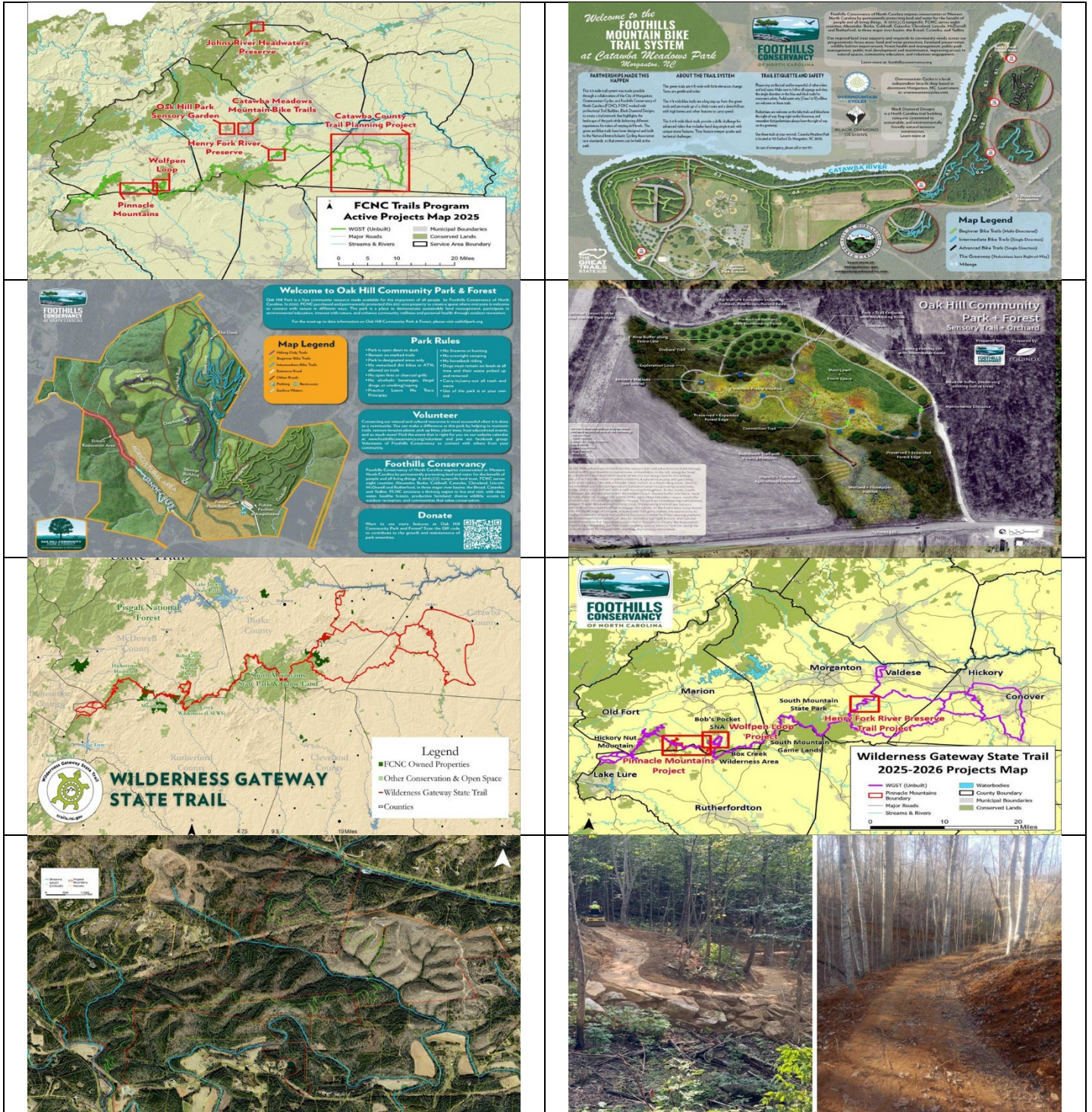
the following message from Mr. Kota: Foothills Conservancy and Lake James State Park recently dedicated a picnic shelter within the park to honor Susie Hamrick Jones and Paul Braun for their leadership in the State Lake James conservation campaign during the late 1990s and early 2000s. The campaign resulted in the State's acquisition of nearly 3,000 acres and approximately 30 miles of shoreline, significantly expanding Lake James State Park and increasing public access for residents of Burke County and beyond. The land had previously been slated for several golf courses and high-density residential development similar to Lake Norman. Director Kota noted that the Burke County Commission and County Planning Department played an instrumental role through their partnership and forward-thinking support. County leadership recognized that conservation and public recreation benefit public health and well-being while also strengthening the local economy. He added that Burke County and Foothills Conservancy have partnered in conservation and public recreation efforts for nearly 30 years and expressed appreciation for the relationship and anticipation of continued collaboration.

Then Mr. Prisby presented an informational update on current projects and initiatives within the County as follows:

Chairman Brittain opened the floor for questions or comments. Commissioner Barrier asked how the trail systems are maintained. Mr. Prisby explained that most trail maintenance is handled by Foothills Conservancy staff and a strong network of dedicated volunteers. Routine and day-to-day work, such as clearing fallen trees, is typically handled in-house; however, some tasks are contracted out when necessary, with the Conservancy prioritizing in-house work for efficiency and cost savings. There being no further discussion, Chairman Brittain called for a motion.

EF - FOREST RESTORATION AND PLANNING

EcoForesters Executive Director, Lang Hornthal, shared an update on forest restoration efforts in Burke County following Hurricane Helene as follows:

EcoForesters' Observations

- Downed trees continue to be an issue, particularly in steeper and roadless areas
 - Landowners are burdened with other costs and most cannot afford to pay for removal
 - Window for viable salvage harvests is closing
- Many oaks were lost and they will need help to compete against NNIS and faster growing trees
- The loss of timber will further harm landowners' ability to pay for forest management

Mr. Hornthal emphasized that forest damage and related risks will be ongoing and stressed the importance of proactive planning, encouraging landowners and local governments to develop forest management plans to establish baseline conditions, guide decision-making, and prioritize damaged areas following recent storms. He highlighted anticipated assistance for private landowners, including a forthcoming state timber loss assistance program and support through the Community Foundation of Western North Carolina Helene Relief Grant, which EcoForesters is using to provide professional expertise and direct assistance in Burke and surrounding counties.

During the discussion, Commissioners asked about future preparedness, equipment needs, debris removal, and prescribed burning. Mr. Hornthal noted that forestry equipment is specialized and costly, making ownership challenging, and that smaller, versatile equipment may be most practical for improving access and reducing wildfire risk. He explained that debris removal is often limited by cost, terrain, and access, with priority given to placing fuels on the ground to decompose and reduce fire risk, and that many landowners lack sufficient resources without additional funding. He also stated that prescribed burns are constrained by access, fuel conditions, and narrow weather windows, though wildfire mitigation funding is increasingly prioritized. There

being no further discussions, Chairman Brittain then called for a motion.

CM – FOSTER CARE PRESENTATION

Brian Epley thanked the Board of Commissioners for their continued focus on foster care and introduced Hope Hembree, a former foster youth and current Burke County DSS social worker, to share her perspective. Ms. Hembree provided a personal account of entering foster care at age six (6) due to parental substance abuse, describing both positive and negative placement experiences, frequent school changes, and the emotional challenges of instability, age-related placement barriers, and group home care.

She highlighted the importance of stable, committed foster parents, supportive and invested social workers, and programs such as NC Reach and LINKS, which helped her obtain a college education and transition successfully into adulthood. Ms. Hembree shared that she was adopted at age 17 and later earned a degree in social work, returning to Burke County DSS as a professional in the same agency that once served her. She emphasized that consistent support, accountability, and belief in foster youth can have lifelong impacts, and encouraged continued investment in foster families and social workers to improve outcomes for children in care.

Chairman Brittain opened the floor for questions or comments. Ms. Hembree received praise from Commissioner Stroud.

Request: Rezone an 11.18-acre parcel from *Residential-One (R-1)* to *Planned Residential Mixed-Use (PRMU)*



REQUEST:

The Community Development Department has received a rezoning application from Ricardo and Kristy Guillen to rezone an 11.18-acre parcel from Residential-One (R-1) to Planned Residential Mixed-Use (PRMU). The property is located off NC 126 between Mast Hook Way and Southpointe

Drive, with access provided via a private right-of-way from NC 126, a state-maintained highway. The applicants recently acquired a right-of-way onto the parcel and are seeking greater flexibility in the allowed use of the land.

SITE ANALYSIS AND SURROUNDING AREA:

The parcel, PIN 176-4093-110, is located within the Linville Township and the Lake James Fire District of Burke County. It lies within the Lake James CA WS-IV watershed and is currently vacant.

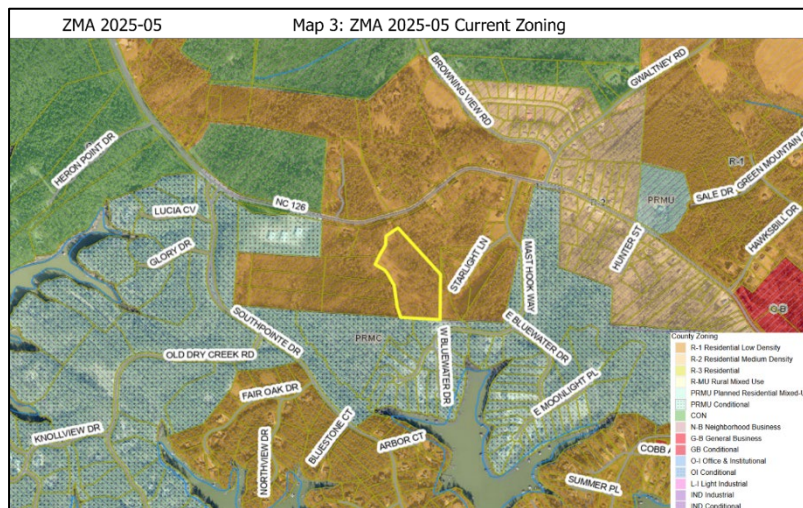
Surrounding Zoning and Land Use:

Direction	Current Zoning	Existing Land Use

The property is near the Water's Edge and Southpointe neighborhoods, both zoned PRMU, which feature a mix of residential and recreational amenities such as pools, tennis courts, and lake access.

CURRENT ZONING:

R-1 (Residential-One) is the most limited residential zoning district in Burke County, permitting only stick-built or modular homes and very limited community services.



PROPOSED ZONING:

PRMU (Planned Residential Mixed-Use) allows for:

- Clustered residential development — a way of building houses closer together on a small part of a larger property to preserve more open space.
- Neighborhood-scale commercial uses are appropriate for scenic or recreation-based areas,

- Master-planned mixed-use developments combining residential, office, and small-scale commercial uses.
- Industrial uses are not permitted. More intensive uses (e.g., apartments, breweries, retail over 3,000 sq. ft.) require a special use permit and site plan review.

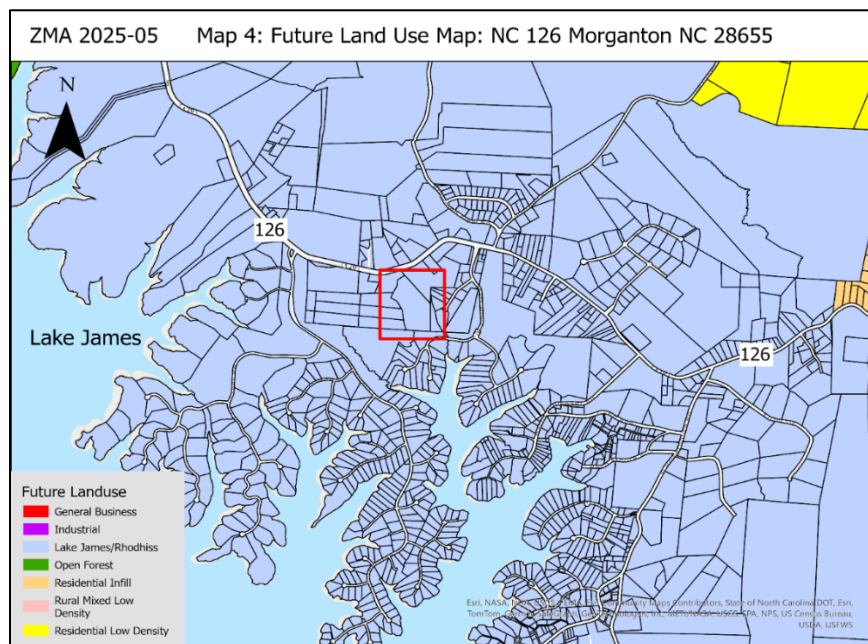
The parcel is also within the Scenic Overlay District, which imposes additional design standards, buffering requirements, and restrictions on certain intensive uses to preserve the area's character.

CONFORMITY WITH THE COMPREHENSIVE PLAN:

The 2022–2030 Blueprint Burke Strategic Land Use Plan designates the parcel as Lake James Scenic on the Future Land Use Map. This category supports:

- Single-family residential and community-oriented development.
- Lake-focused commercial uses such as restaurants, resorts, and tourism-based businesses.

The requested PRMU zoning is consistent with the Future Land Use Map and the plan's goals for this area.



PLANNING BOARD RECOMMENDATION:

The Planning Board provides a recommendation to the Board of Commissioners for each map amendment or text amendment. At the August 28, 2025, Planning Board meeting, the case was reviewed. The applicant spoke about the need for greater flexibility in land use and expressed enthusiasm for the property's future as a family asset. No public comments were made. The Board voted unanimously to support the rezoning request.

Chairman Brittain opened the floor for questions or comments; there being none, he opened the public hearing at 7:25 p.m. The Public Hearing Notice was published in the News Herald on October 9 and 16, 2025. Further, the notice was also posted on the County's website

(www.burkenc.org) on October 9, 2025. There being no one present to address the Board, the public hearing was closed at 7:25 p.m. He then called for a motion.

Motion: To adopt Ordinance No. 2025-11 as it relates to ZMA 2025-05 for the parcel corresponding to PIN 1764-09-3110 to rezone said parcel from Residential-One (R-1) to Planned Residential Mixed-Use (PRMU) because it is consistent with the Future Land Use Map designation of Lake James Scenic. Further, the request is reasonable and in the public interest because:

- **The surrounding land uses and zoning, including adjacent PRMU neighborhoods, support the rezoning.**
- **The Scenic Overlay District encourages flexible, character-matching planned development while regulating intensive uses.**

An Ordinance Amending the Official Burke County Zoning Map
ZMA 2025-05

Be it ordained that the Official Burke County Zoning Map is hereby amended as follows:

A single parcel totaling 11.18-acres located at 4111 NC 126, Morganton, N.C., and identified by PIN: 1764-09-3110 shall be rezoned from the Residential One (R-1) district to Planned Residential Mixed Use.

Consistency Statement

The Commissioners find that the request to rezone ZMA 2025-05, an 11.18-acre parcel located at 4111 NC 126, Morganton (PIN 1764-09-3110) from the Residential-1 (R-1) District to the Planned Residential Mixed-Use (PRMU) District, is consistent with the Future Land Use Map, which designates this area as "Lake James Scenic" and supports single-family residential development and community-oriented, lake-focused commercial uses. The proposed PRMU zoning is also consistent with the character of the area, as it is compatible with the adjacent PRMU-zoned neighborhoods and is located within the Scenic Overlay District, which encourages planned development that is in harmony with the area's character. Furthermore, the PRMU district provides for a mix of residential and neighborhood-scale commercial uses, with regulatory oversight through the special use permit process to ensure compatibility with surrounding uses.

INFORMAL PUBLIC COMMENTS

Chairman Brittain called for informal public comments and asked speakers to limit their comments to three (3) minutes.

Cristy Gupton, 200 Laforet Drive, highlighted the benefits of Direct Primary Care (DPC) as an alternative healthcare model. She explained that DPC uses a flat monthly membership fee to provide patients with unlimited primary care access, longer appointments, and direct communication with physicians, reducing administrative costs and reliance on insurance. Ms. Gupton stated that DPC improves access, lowers overall healthcare spending, reduces unnecessary emergency room use, and supports better chronic care management and more responsible opioid prescribing. She shared her personal experience as a DPC patient for over five (5) years and noted growing national and local interest in the model, including one existing DPC clinic in Burke County. She encouraged community leaders to support awareness and expansion of DPC.

There was no one else to address the Board; therefore, Chairman Brittain closed this portion of the meeting.

CONSENT AGENDA

At the request of the Board, Brian Epley, County Manager, reviewed the following five (5) items on the consent agenda, which were approved by a single motion.

CLERK - APPOINTMENT TO THE AMERICA 250 NC COMMITTEE

Mr. Kevin Hancock previously occupied Seat No. 10 on the America 250 NC Committee, representing the Sons of the American Revolution (SAR), until his resignation and removal during the Board of Commissioners' August 18, 2025, meeting. The SAR Chapter recently formed an America 250 Committee to support the upcoming commemoration. To fill this vacancy, Mr. Charles Woodie of the Col. Alexander Erwin SAR Chapter (CAESAR) applied. He currently serves as Vice President of the Chapter and as Chair of the SAR's newly established America 250 Committee.

Motion: To appoint Charles Woodie to Seat No. 10, Sons of the American Revolution, on the America 250 NC Committee to complete the remainder of a term ending April 16, 2027, and to grant an exception to Section 2-88, membership requirements of the Burke County Code of Ordinances.

CM - BUDGET AMENDMENT NO. 3 - \$122,000

This budget amendment recognizes funds received from the State of North Carolina to the health department as part of statewide funding AA 122, to be used for post-hurricane Helene recovery

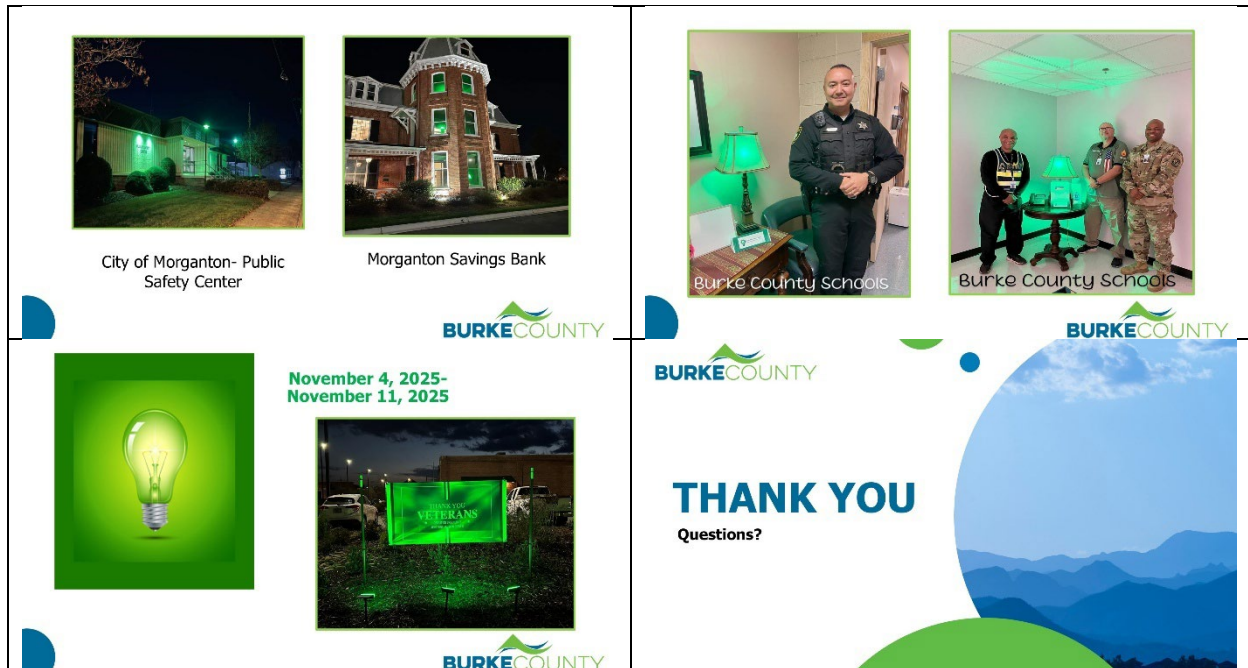

WHEREAS, the residents of Burke County have great respect, admiration, and the utmost gratitude for all of the men and women who have selflessly served our country and this community in the Armed Forces; and

WHEREAS, the contributions and sacrifices of the men and women who served in the Armed Forces have been vital in maintaining the freedoms and way of life enjoyed by our citizens; and

WHEREAS, Burke County seeks to honor these individuals who have paid the high price for freedom by placing themselves in harm's way for the good of all; and

RESOLUTION APPROVING APPOINTMENT OF AGENT
FOR THE CONSTRUCTION OF THE PROJECT

WHEREAS, the Burke County Board of Education (the "Board") has been awarded a state grant in the amount of \$42,000,000 from Education Lottery proceeds to construct the Eastern Burke County Elementary School (the "Project");

WHEREAS, by resolution dated March 17, 2025, the Burke County Board of Commissioners (the "County") duly adopted a resolution approving the purchase price offered by the Board to acquire certain property located in Hildebran, Burke County, NC (the "Property") upon which to construct the Project, and the Board has now acquired the Property;

WHEREAS, the estimated cost of the Project exceeds the state grant award, and the Board hereby requests the appropriation of \$13,000,000 from the School Capital Fund Balance to provide both the required matching funds and the additional funds necessary to construct the Project;

WHEREAS, the County adopted a project ordinance in the amount of \$55 million for an elementary school construction project in June 2024; and

WHEREAS, the County and the Board recognize their joint obligation to provide adequate educational facilities for residents of the County, and further particularly appreciate the importance of the Project in meeting the educational and facility needs of students and the community; and

WHEREAS, the parties find it to be in the best interests of Burke County and the accomplishment of the Project to ensure the timely completion of the Project by empowering their respective officers, agents, and employees to act as necessary to advance the Project to construction;

NOW THEREFORE BE IT RESOLVED, BY THE COUNTY OF BURKE, ACTING BY AND THROUGH THE BOARD OF COMMISSIONERS, AS FOLLOWS:

Section 1. Appropriation. The County hereby authorizes the appropriation of \$13,000,000 from the School Capital Fund Balance for the Eastern Burke County Elementary School Project, supplementing the \$42,000,000 state grant award received by the Board.

Section 2. Lease of Property. The Board hereby leases the Property to the County solely for the purposes outlined in this Resolution. The lease shall begin on the date this Resolution has been adopted by both parties and continue through the completion of the Project. The lease shall terminate when the Project is completed, and all payments have been made to the contractor(s). The parties' mutual desire to seek reimbursement of sales tax shall serve as consideration for this lease. This lease shall provide the County with full access to the Property as may be necessary for the completion of all phases of the Project, subject only to any applicable written policies of the Board regarding access to and conduct on school properties. Except for this limited grant of access to the County, the Board shall retain, at all times throughout the term of the lease, full and exclusive rights to own, possess, use, and occupy the Property in any manner it deems advisable. In addition, the Board retains full discretion throughout the term of the lease to transfer any property interest(s) in the Property, including but not limited to any easements and rights of way, without providing prior notice to or seeking the approval of the County. The parties agree that this paragraph shall serve as the lease of Property by the County and that no other documentation of said lease shall be required, except that either party shall have the right to prepare and file a Memorandum of Lease with the Burke County Register of Deeds.

Section 3. Appointment of Agent for Construction of Project. The County hereby appoints the Board and the Board hereby agrees to accept such appointment to be responsible for the selection of architects, engineers, and constructors of the Project in accordance with applicable law. The Board agrees to cause the Board and County to be named parties to contracts for the same. The Board agrees thereafter to be solely responsible for the management and construction of the Project.

Section 4. Expenditures, Sales and Use Tax Refund Application Authorized. The County Finance Officer is hereby authorized to i) expend funds from the Education Lottery grant and the supplemental appropriation from the School Capital Fund Balance, such amounts as the Project architect shall certify as payable and the Board shall approve for payment; and ii) apply for refunds of expenditures eligible for refund pursuant to N.C. Gen. Stat. § 105-164.14(c) and expend such refunds for construction of the Project.

Section 5. Statutory Authority. The terms listed herein are contractual pursuant to N.C. Gen. Stat. §§ 160A-247 ("Sale, lease, exchange and joint use of governmental property"), 160A-461 ("Interlocal cooperation authorized") and 160A-466 ("Revenue and expenditures for joint undertakings").
